

**REQUEST FOR MOVEMENT OF MILK, FEED OR BEDDING
AT LEGAL WEIGHTS ON SEASONAL ROUTES
DURING SPRING WEIGHT RESTRICTIONS**

In compliance with Sec. 722, Public Act 300 of 1949, as amended, the following information is required to be submitted in writing by the hauler requesting to transport legal weight loads on a seasonal highway during weight restrictions.

APPROVAL BY THE BOARD OF NEWAYGO COUNTY ROAD COMMISSIONERS FOR THE REQUESTED ROUTE ON THIS APPLICATION CONSTITUTES A PERMIT IN COMPLIANCE WITH SEC. 722, P.A. 300 OF 1949, AS AMENDED, UNDER THE FOLLOWING CONDITIONS AND RESTRICTIONS:

1. Permit must be carried in the vehicle(s).
2. Speed limit not to exceed 35 m.p.h.
3. Normal legal loadings only.
4. Time of day: mornings if possible
5. The Board of Newaygo County Road Commissioners have the right to suspend this agreement if weather or road conditions warrant such action.
6. Any of the following actions shall immediately void the permit and subject the applicant to appropriate legal action: (a) Misrepresentation of information set forth in an application for permit; (b) Noncompliance with the conditions, restrictions, or provisions on which a permit is issued; (c) A change or erasure on a permit.
7. The permittee shall be responsible for damages to the highway, to persons, and to property caused by or arising from operations covered by this permit. The permittee shall indemnify and save harmless the Transportation Commission, the department and all of their employees from any and all suits, claims, and damages of every kind arising out of, under, or by reason of this permit, or from operations covered by this permit.
