PERMIT TYPE:

FEE

UTILITY

- Utility Blanket Permit (covers maintenance of existing utilities in ROW) \$100.00
- Aerial Crossing \$30.00
- Bore under the roadway \$50.00
- Trench across the roadway \$90.00
- Trenched utilities/parallel bore \$0.10 per lineal ft. Min. - \$50.00 Max. - \$500.00

COMMUNICATION SERVICE PROVIDER (CSP)

- Project Permit Fee
 - o \$300 or \$1,000 total for all permits per project
- Annual Routine Maintenance/Repair Permit Fee
 - o \$300 annually
- Permits for Non-Routine Work Fee
 - o \$300 or \$1,000 total for all permits per project

Bond requirement - \$20,000

Insurance requirement with N.C.R.C. listed as additional insured

- Min. \$2,000,000 per occurrence for property damage
- Min. \$2,000,000 per occurrence for bodily injury in perpetuity

WORKING IN ROAD RIGHT-OF-WAY

CONSTRUCTION

Residential Driveway/Field Drive

- New Construction \$30.00
- Resurface or repair \$30.00

Commercial Driveway Approach/Private Street

- New construction \$200.00
- Min. bond or letter of credit \$5,000.00
- Resurface \$30.00

Plat or Site Condominium

- Preliminary plat review \$350.00
- Construction plan review/per 500 ft. \$180.00

TRANSPORTATION PERMITS

- Annual moving permit \$100.00
- Single move permit \$25.00

SEASONAL WEIGHT RESTRICTIONS

- Agricultural per day, per number of trips, or for a certain time of day \$25.00
- Milk Haulers - Approved routes and times per vehicle \$25.00
- CRA110 – moving permits for utility companies during weight restrictions \$100.00

Bonding-

- Blanket permit (covers all vehicles and equipment) \$250.00
- Minimum requirement up to 0.5 mile \$5,000.00
- Minimum per mile \$10,000.00

ROAD ABANDONMENT

\$750.00

AFTER THE FACT PERMIT

3X ORIGINAL PERMIT FEE

In the event of a failure to comply with the terms or conditions of any permit issued in accordance with these rules or failure to obtain an appropriate permit, the Newaygo County Road Commission shall have the right to halt such activity until such time that adequate compliance is made. All costs incurred by the Board in correcting 1) a failure to comply with the conditions and standards of a permit; 2) a failure to obtain a permit; or 3) defective workmanship or materials, shall be borne by the applicant (or person undertaking the activity.)
