ICE CONTROL SAND SPECIFICATIONS

Delivery to be made on or before November 1, 2026, if the complete order has not been delivered by this date, there will be a penalty of \$500.00 per day assessed until the complete order is delivered. Payment will not be made until the complete order has been delivered.

The price per ton shall include the use of a diesel powered, radial stacker with feed hopper. The minimum acceptable length of the stacker shall be 100 feet.

The Road Commission will provide a loader and operator to feed the stacker.

Material will be tested and approved by the Newaygo County Road Commission.

RENEWAL OPTION: The Road Commission reserves the right to renew the contract for two additional one-year terms, each upon mutual agreement of both parties.
