SPECIFICATIONS FOR STATE HIGHWAY STREET SWEEPING

LOCATION: Grant on M-37 (1.87 Miles)
Newaygo on M-37 & M-82 (5.84 Miles)
White Cloud on M-20 (1.18 Miles)
Fremont on M-82 (1.48 Miles)
*Additional locations listed on next page

SERVICE: 1 sweep with the possibility of a 2nd sweep, if approved by MDOT

COUNTY ROADS: If agreed by both parties, this contract may include County Road Street sweeping at set price quoted for State per mile.

DETAILED DESCRIPTION:

Furnish all equipment and labor to sweep as directed by Newaygo County Road Commission.

This contract based upon satisfactory performance by the contractor, will be evaluated at the end of the contract year. **This is a 1-year contract with the option to be extended up to 2 additional years at the same price with mutual agreement by both parties.** N.C.R.C. has the right to cancel the contract at any time if contractor performance is unsatisfactory. First year of service starts 2026 and may be extended up to 2028.

MINIMUM INSURANCE REQUIREMENTS

The Road Commission and Newaygo County will be held harmless for any claims related to Sweeping operation.

The contractor shall furnish proof of insurance of the following types and in the following amounts:

Workers Compensation – as set by State Statute
Automobile Liability \$1,000,000 CSL
General Liability \$ 500,000 CSL
Employer's Liability \$ 100,000 CSL

Newaygo County Road Commission and the Board of County Road Commissioners of Newaygo County must be named as additional insured.

DEBRIS DISPOSAL

The successful bidder will be responsible/liable for the proper and legal disposal of all materials collected from routine and special sweeping operations. Arrangements with others relating to transporting, stockpiling and/or disposal, along with the fees involved, shall be the responsibility of the successful bidder for Highway roads. The manifest and disposal will be included for County roads also. The cost for disposal from county road system shall be included in bid price as well. Disposal manifests must be obtained and submitted to the Road Commission as proof of proper disposal. No payment for work completed will be made until manifests/delivery receipts are received by NCRC.
