Warranty: Standard factory warranty, must include definition

Bid Form:

- a) Bid must be submitted on bid form and detailed in its entirety or bid may be rejected.
- b) These specifications are to be met to the best ability of the Manufacturer and Dealer and any deviations from these specifications must be stated clearly on the bid form.

Submission of bid will be construed as a conclusive presumption that the Contractor is thoroughly familiar with the bid requirements and specifications and that he/she understands and agrees to abide by each and all of the stipulations and requirements contained therein.

Neither the Contractor nor his/her subcontractors shall discriminate against any employee or applicant for employment, to be employed in the performance of this Contract, with respect to his/her hire, tenure, terms, conditions, or privileges of employment, or any matter directly or indirectly related to employment because of his/her race, color, religion, national origin, or ancestry. Load Capacity: Pay load 40,000# minimum

Deck Length & Width:

- a) 28 ft to 30 ft. deck
- b) Overall width of trailer to be 102"
- c) 12 tie down D rings equally spaced

Tilt Platform Construction:

- a) Tilted deck angle 12 degrees or less
- b) Fold down approach plate and underride protection air operated
- c) Two platform cushioning cylinders (hyd)

Tongue Type & Size:

- a) 20,000# vertical capacity and 60,000# pull
- b) 3" adjustable pintle hitch with 17" to 26" adjustment
- c) Safety chains w/hooks to match trailer cap., ample strength entire G.V.W.R.
- d) Tool chain box within tongues dimension

Decking Material: Nominal Hardwood

Axles: Tandem dual with oil bath seal hubs, disc wheels with pilot hubs (outboard drums)

Tires: 215/75R x 17.5-16 PR radial tires

Brakes:

- a) Air brakes, S-cam, all axles, match G.V.W.R.
- b) Anti lock brakes all
- c) Self adjusting
- d) Parking spring brake on at least one axle
